

THIS DEED OF TRUST made at Kondalia on the 16th day of October, Two thousand Nine by SAMIRAN KUMAR DAS, son of Sri Sarat Chandra Das, aged about 44 years, residing at Kondalia, P.O. Parulia, P.S. Suti in the District of Murshidabad, hereinafter referred to 'THE AUTHOR OF THE TRUST'.

WHEREAS the Author is desirous of forming a Trust for the purpose of imparting education and charity and has, for this purpose contributed a sum of Rs.10,000.00 (Rupees Ten thousand only) towards the corpus of the Trust.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

- 1. The name of the Trust shall be **NETAJI SOCIAL WELFARE TRUST.**
- 2. The Office of the Trust shall be situated as Bhabki, P.O. Mahesail, P.S. Suti in the District of Murshidabad and the address may be changed as and when found necessary by the Trustees.
- 3. The objects of the Trust shall be any or all of the following:
 - (a) To promote spiritual, physical, mental, educational development and upliftment of adult and children of all ages without any distinction of caste, creed or religion and in the interest of mankind in general.
 - (b) To aid or establish, takeover or collaborate with any Institution or School or College or Association, for physical, mental, spiritual, educational development, uplift of intelligence or its development.
 - (c) To provide for medical relief of the poor and the sick and to establish, promote, run, maintain and aid industrial centers, or order to provide jobs and the unemployed, hospitals, ambulances, nursing homes, charitable dispensaries, maternity and child welfare centers and such other charitable institution.
 - (d) To organize and distribute relief in case the famine, flood, epidemics, fire, earthquake and other pestilences breaking out and to contribute towards any other institutions of fund devoted to the promotion of relief or other charitable objects.
 - (e) To fund, promote, establish, develop and organize colonies and townships for members and other subscribing to the social and cultural ideas of the society.
 - (f) To aid or establish any institution or adopt means for imparting, promotion of art, science or any other field of education, propagate for removal of social evils, customs or render or promote self-help to overcome any of these evils particularly for the poor of weaker section of the society.
 - (g) To promote and develop the conditions of health, education, means of communication or other aspects of civilized life in such areas as may be deemed expedient.
 - (i) To raise and accept subscriptions, donations, gifts, benefactions, endowments and charities and to raise money by organizing charity shows, through levy or contribution made and through all other lawful means for the objects and purposes and activities of

- (k) To render help, arrange for and encourage and promote celebrations of National, cultural, social and such other festivals and jayanties as conducive to this object. Provided, however, that any contribution by the societies to or cooperation with any other society or project having as its sole objects all or any of the aforesaid object shall mean furtherance of the objects of this society.
 - (l) To purchase, take on lease or otherwise, acquire and to sell, give on lease or otherwise, dispose of movable and immovable properties of any description and to acquire, hold and sell stocks, securities and other investments.
 - (m) To frame statutes, rules, regulations and bye-laws and alter, amend, modify and rescind the same.
 - (n) To do all such other things as are incidental and conductive to the attainment of the above objects or any one of them.

 - 2. Supti Das, aged 36 years, wife of Sri Bilash Kumar Das, residing at Vill- Kondalia, P.O. Parulia, P.S. Suti in the District of Murshidabad.
 - 3. Sunil Kumar Das aged 54 years, son of Sri Sarat Chandra Das residing at Vill- Kondalia, P.O. Parulia, P.S. Suti in the District of Murshidabad.
 - 4. Barun Kumar Das aged 36 years, son of Sri Sudhir Kumar Das, residing at Vill-Sadikpur, P.O. Sadikpur, P.S. Suti in the District of Murshidabad
 - 5. Biswajit Das aged 47 years, son of Late Amiya Kumar Das, residing at Vill- Asrampara, P.O. Aurangabad, P.S. Suti in the District of Murshidabad
 - 6. Amal Kumar Roy, aged 50 years, son of Late Rebati Mohan Ray, residing at Vill-Collegepara, P.O. Aurangabad, P.S. Suti in the District of Murshidabad
 - 7. Tarun Kumar Saha, aged 43 years, son of Sri Ajit Kumar Saha residing at Vill- Collegepara, P.O. Aurangabad, P.S. Suti in the District of Murshidabad

- (c) The other Trustees shall retire by rotation in two at a time, the first Trustees shall continue for three yeas from the date of the Trust Deed. The retiring Trustees will be eligible to be co-opted for further periods.
- (d) The Board of Trustees shall at their discretion co-opt any person or persons who may be helpful in achieving the objects of the Trust as a Trustee.
- (e) The maximum number of Trustees shall not exceed eight.
- (f) A Trustees shall cease to hold office of Trust on the Trustees becoming insane or launatic.

5. MANAGEMENT

- (a) The Management, control of the property and affairs of the Trust aforesaid shall vested in the Trustees with full powers and authority to purchase or hold any land or hereditament and construct any building for the object of the Trust or any funds or any other properties or investment at any time, subject to the Trust of these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they deem fit and to alter or vary the same from time to time to make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and intents of these presents and not inconsistent with the provisions of Section 2 (15), 11 to 13 and 80-G of the Income Tax Act, 1961.
- (b) The Trustees shall meet as often as possible but not less than three times in a year for efficient management of Trust, to consider the income and expenditure and for disposing of all such other matters as may arise in such meeting.
- (c) At all meeting of the Trustees, four members will form quorum.
- (d) At all meeting of the Trustees, Managing Trustee or in his absence any other Trustee shall be the Chairman and all decisions of the Trustees shall be by majority of vote, and the Chairman shall have as casting vote in the case of equality of votes.
- (e) All proceedings of the meeting of the Trustees shall be recorded in a Minutes Book kept for the purpose.
- (f) Trustees who fail to attend four consecutive meetings without prior intimation or information shall cease to be Trustees, unless otherwise majority of the other Trustees accord him exception on genuine and valid grounds.
- (g) In case of any difference of opinion between the Trustees in any matter connected with the Trust and its administration the decision of the majority will be final and binding on all the Trustees.

6. **POWER OF TRUSTEES**:

- (a) To manage Trust Funds and collect and recover the interest, income and profits thereof and to pay there out the expenses of collection and other outgoing, if any.
- (b) The Trustees shall have all powers specifically conferred to do things as may be required

Trustees shall be entitled from time to the sale of th

- (c) The Trustees shall be entitled from time to time to open, maintain and operate a Bank account or accounts in the name of the Trust or in the name of the School or Schools or Institutions at such Bank or Banks as they may from time to time decide and may at any time pay or cause to be paid any monies forming part of the Trust Fund/School Fund or the income thereof to the credit of any such account or accounts either by way of Fixed or Current Account or any other account. Any such account shall be operated upon jointly by the Treasurer and any one out of The Chairman and The Secretary.
- (d) The Trustees shall have powers to maintain and defend all such suits and take such other steps as may be reasonable and requisite for the preservation of the Trust Property and the protection of the title thereof. At the discretion of the Trustees, the Managing Trustee, or any other Trustee or Trustees or such other authorized person or persons shall represent them in all such proceedings.
- (e) The Trustees are bound by all the liabilities cast upon them under the Indian Trust Act of 1882 except to the extent of the powers specifically conferred under these presents.
- (f) The Trustees at their discretion may sell any immovable property or properties which may for the time being responsible for any loss that may thereby be incurred and in case of such sale, to execute and to do all such deeds and acts for the purpose of carrying such sale shall be deemed to be part of the Trust Estate and shall applied accordingly.
- (g) The Trustees may at any time receive voluntary contributions from any person or persons by donation, legacy, gift, annual or monthly subscription for the benefit of the Trust. The Trustees shall apply such contribution in accordance with the objects of the Trust.
- (h) Proper accounts showing all receipts and disbursements made on account of the Trust hereby constituted shall be kept by the Trustees who shall prepare Receipts and Payments Account, Income and Expenditure Account and Balance Sheet as on March 31 every years and shall be duly audited by a qualified Chartered Accountants.
- (i) The Trustees may from time to time appoint any Accountant, Clerk and other Officials and employees as the Trustees may deem expedient, and fix and pay their remuneration out of the Trust Fund or the income thereof.
- (j) The Trustees shall have power to raise or borrow for the purposes of Trust from time to time in the name of the Trust or otherwise on behalf of the Trust such sums of money as they may from time to time deem expedient either on the mortgage of the whole or any part of the property of the Trust, or by bonds, debentures, deposit receipts, promissory notes, with or

- In the event of the dissolution or the winding up of the Trust the assets remaining on the 7. dissolution shall be transferred to another Trust, Society or Institution whose objects are similar to those of this Trust and that in no event shall the assets so remaining be distributed among the Trustees.
- The terms and conditions of the Deed of Trust shall not be amended without obtaining the prior written consent of the Commissioner of Income Tax.
